- 1. The Capital Development Authority (CDA) (A Public Sector Procuring Agency) on behalf of the Ministry of Health, Government of Pakistan, invites proposals on Single Stage Two Envelope bidding procedure under Rule 36 (b) of Public Procurement Regulatory Authority-2004, for the hiring of International consultancy services for detailed Design Review, Technical Professional Advisory Services, and comprehensive Project Management solution of Jinnah Medical Complex & Research Center, Islamabad, Pakistan; a state-of-the-art, 1,200-bed tertiary care hospital and research center. Online registration on EPADS (a digital portal) is mandatory to download the RFP and submit the bid.

A Bid Security must accompany all proposals in the shape of a Pay Order or a Bid Bond in favor of DDO (P&C), CDA issued by any scheduled bank recognized by the State Bank of Pakistan, amounting to PKR. 30.00 million (or an equal amount in foreign currency) must be submitted along with the Technical Proposal. A copy of the Bid Security shall be uploaded on EPADS in PDF format. The original Bid Security shall be submitted to the office of the Director (P&CA-I) on or before the closing date and time of the proposal.
- 4. Prospective bidders are required to submit their proposals online through EPADS at https://www.eprocure.gov.pk on or before 10th June 2025 at 1700 hrs. The technical proposals will be opened at 1730 hrs on the same day in the presence of the Bidder's representative at the address mentioned below.


